



Resource Caregivers me Child Caring Institution (CCI) caregivers repwe eaea ewe reasonable me prudent parent standard ar repwe sinei ika repwe mwut ngeni ewe semirit/serafo ar repwe fiti ekkewe pekin mwokutukut ren extracurricular, social, me cultural activities.

Ewe chon angangan CWS me ewe Resource Caregiver ika CCI caregiver repwe angang fengen ar repwe sinei ekkewe sakkun mwokutukut mei eoch ngeni ekkewe semirit/serafo non foster care. Ekkei kapas eis me ponuwan ra katou an epwe anisuk nge ese pinei ekkoch mettoch ika porausan mettoch. **Ponuwan:** Ewer. MEINISIN semirit/serafo ir mei nomw non foster care, ika mwo repwe nomw non ew resource family home ika non ew Nenien Child Caring, ir mei need ekkei fansoun ren ukukun ewe ier ir mei nonom non. Ei mei pachenong ar repwe participate non social activities, dating, churi chiener, pworuk non sukun, eoreni, namanam, me mwokutukutun aterenges. Emon semirit/serafo epwe fiti urumwot (sports), ika epwe non ar nenian sukun ika non chok nenier mei pwan eoch pun ina part of them being a child, ika ina met semirit ir mei fifiti.

**Ponuwan:** *Ewer*, ren mwumutan seni CWS, ewe Family Court, ewe GAL, me iin/sam. Resource Caregivers mi pwan mumuta ar repwe uwei nour semirit/serafo on vacation.

Ei mei mumuta **advance planning** ngeni ewe Resource Caregiver, ewe chon angangan CWS me Family Court ika epwe meni wor ekkoch tetenin epwe fis fanitan ewe semirit/serafo ar repwe saai (katon en fan). Asinei ngeni iin/sam me mwan kopweakkota omw saai me awewei ifa usun ewe semirit/serafo epwe feieoch seni ei mwokutukut iwe epwe anisi iin/sam ar repwe kinamwe/pwapwaiti ar repwe anisi nour kewe non ar saai.

Fan mi wor ekkewe procedures ren Child Welfare Services fanitan an semirit/serafo repwe fiti nour resource caregiver ne saai.

**Voluntary Foster Care:** ngeni semirit/serafo re saai ngeni nukun fiti ewe resource caregiver, noun ewe semirit chon angang epwe fori an angang ne ureni ekkewe iin/sam me angei ar mwumuta. Ika ekkewe iin/sam rese mochen, ewe semirit/serafo rese tongeni saai. Ika ekkewe iin/sam ir mei tipeew ngeni an ewe semirit epwe sai, ewe chon angangan CWS epwe angei echo taropwen mumuta seni ekkewe iin/sam.

**Foster Care (court case):** Ren emon semirit/serafo an epwe saai ngeni nukun fiti ewe resource caregiver, noun ewe semirit chon angang epwe asinei ngeni ekkewe iin/sam me angei mwumuta. Ika mi mwumuta seni iin/sam me CASA/GAL, ewe Department epwe asinei ngeni ewe court pun esapw wor objections seni iin/sam me CASA/GAL me pwan ngeni court ranin ewe saai me neni, auchean ewe saai me ian ewe semirit/serafo me ewe resource caregiver repwe nomw ian.

Ika epwe wor anini seni iin/sam ika CASA/GAL ngeni an ewe semirit/serafo fiti ewe resource caregiver ne sai, ewe Department epwe tungorei ewe Department of Attorney General (DAG) an epwe file ew atutur/komplein. Ewe Family Court epwe sine ewe mettoch me uwau ewe finata ika pun ewe semirit/serafo mei tongeni saai.
