Nonomwoch me Kinamwe - Pwata E Aucheia ngeni Semirit me Serafo non Foster Care

Seni met ra nenengeni ren mamaritan semirit me serafo, "nonomwoch" a wewe ngeni aukukun ier me fefeitan mwokutukut, sinei, me fansoun an epwe fori mwokutukutun serafo iteitan ran an epwe watte me etiwa "nonomwoch" och mettoch mei wires non nonomwun emon semirit me serafo (fan annukun ewe Center for Study of Social policy, 2014).

Met famini mi fofori ngeni nour kewe semirit me serafo ina met ekkewe semirit non foster care re need ren fetaneochun nonomwur/mamawer. Sopwosopwonon eochun non famini a aninis ren **pekin appet** seni mwokutukut mi afeiengaw ren an ekkewe semirit/serafo repwe tonong non (Moretti & Peled, 2004). Ika mwo fanitan nonomwun serafo me ririn nefiner ngeni ar famini mi nikasiwin iteitan, nge mei chok wor auchean ar famini ngenir mi fokkun auchea fanitan nonomwur (Howe, et al., 1999). Non chok ena atun, participation non extracurricular me social activities mi tongeni siwini manawan chommong semirit ar repwe siwin ngeni manawan serafo.

Nupwen ekkewe semirit rese mwo tongeni fiti ekkewe mwokutukut re need ar repwe mamarita, rese mwo moneta ar repwe usun ekkewe ra watte ika serafo. Chommong semirit ra watteno me non ekkewe nenian tumwun ra experiencini unemployment me nafangawan moni tonong, homeless, me kanapwus.

Ren pekin kutten porausan non tupwuwan serafo a fateno pwata ekkei sakkun nikinik mi weires ngeni mamaritan semirit. Wattenon kaeo nupwen omw serafo mei fokkun auchea me nepoputan omw chiwen kukun. Mamaritan semirit a fis non tupwuwan serafo non ar frontal lobes, non ewe prefrontal cortex, a wisen nemeni ar ekiek, monota, finata, pwungupwung, me nukunuk. Chemicals non mokur e mwokut nupwen ar fansoun mamarita, a ngeni ewe aramas ukukun met e need an epwe sotuni ne fori mwokutukutun serafo ika me ar angang. Pwan chok non ena atun, serafo ra fokkun chengen, pwan siwin nikinikir, me mochen sinei ika fori ekkoch minafon nikinik me sotuni ar repwe pusin fori on pusin ar.

Ewe mamarita ren tupwuwan serafo a awora ew "asamen/anen ar fansoun." Pokitan riri fengen ina kian fefeitan me nepoputan, riri-fengen mi sopwosopwono non nonomun serafo. Aninisin chon tumwun mi need an epwe anisi ekkewe semirit ar repwe kutta non ei fansoun ne ngenir "normal" fofor me anisir ar repwe ekieki met ar finata non nonomwur/manawer (Henderson, 2011; Farruggia, 2006).

Sopwosopwonon, semirit me serafo non nenian tumwun ar repwe tongeni forata ar social capital ika nonomwun manawer. Social capital ewe "auchea mi foruta seni met en mi wanong non ewe relationship ngeni ekkoch ren omw nukunuk me nikasiwinin mettoch" (JLC, 2015).

Wewen:

“Anonganong won Taween-lerin” wewen ew mwokutukut ika mettoch mei ketiwnengen iemon semirit non aukukun ierin ika an sinei. Taween-lerin mi anonganong on mamaritan ekiekin, mwokutukutun, nikinikin, me foforan iemon mei wewe ngeni ierin ika aukukun non ew mwich. Fanitan iemon semirit, mwokutukut ika mettoch mei eoch ngeni ewe semirit anonganong on ewe keukun ewe semirit mei tori ren an sinei sufon, me keukun an mwokutukut.

“Resource Famini” ika **“chon tumwunun resource”** wewen ew famini ika iemon aramas ika ew mettoch mei affat fanitan ew nenian tumwunun semirit mi: (1) Wor noun Laisen seni ewe Department of Human Services an epwe awora aninisin temporary safe foster care ngeni semirit mi nomw fan ewe jurisdiction ren ewe kinikin ren tumwun menukun iimw.

“Nenien Tumwunu Semirit” ika **“group home”** wewen ekkoch neni mi license seni ewe department, fanitan ewe ar angei onomen kukun semirit ika nap seni onomen seni ekkewe iin/am ika chon tumwunur non chok och mochomochan fansoun ren ar repwe tumwunur, me isonir non ukukun rue-me -ruanu awa nge mi kamo.

“CCI Caregiver” ei taropwe a for fanitan ekkewe CCI caregiver on ewe angang mi wewe ngeni ekkewe ra kefinita ar repwe tumwunu ekkewe semirit non ewe nenian tumwunun semirit ika Child Caring Institution (CCI) ika iemon on-site CCI caregiver, wewen iemon chon tumwunu semirit me non ew neni mi nomw fan pwungun ew Child Caring Institution (CCI). Ew me ew CCI mi affat an iemon chon angang epwe nomw on-site pwe epwe iemon "chon tumwun" ika iemon on-site "caregiver" epwe wisan fori an iin/sam angang ngeni iemon me iemon ekkewe semirit. Meinisin shifts mi need an epwe finata iemon chon tumwun epwe nomw on-site mi fen resif training ren ewe reasonable me prudent parent standard iwe an epwe wisan fori me finata ika anisi ewe semirit ika serafo ren met mei tufich ngeni ierin. Ewe aramas epwe i iemon chon tumwun, esapw iemon seni ew committee ika chon non offes.

“Qualified Immunity”-(usun mi affat non HRS 346-17) ew me nein ekkei resource caregiver ika child caring institution repwe uwau ew certificate ren approval ren ei kinikin epwe immune seni liability non ewe civil action an epwe recover damages ika feiengaw, mano, ika poutuno ngeni iemon aramas ika pisek mi results seni authorizing iemon semirit fan tumwunuwan iemon chon tumwun me non ewe neni an epwe participate non ewe extracurricular, enrichment, cultural, ika social activity; mi kawor an ewe authorization epwe nom non accordance ngeni ewe reasonable me prudent parent standard mi affat non itenap 42 United States Code section 675 (10) (A).

“Reasonable me prudent parent standard” wewen ewe standart characterized seni tumwunun me mefian iin/sam ewe a tumwunu me appeti tumwunun ewe semirit me apochokuna mamaritan ewe semirit, ren an ewe resource caregiver me on-site CCI caregiver repwe eaea nupwen repwe mwut ngeni ewe semirit an epwe fori sakopaten nikinik, non sukul, nukun sukul, pachanong pwan ekkoch activities.

NONOMWOCHUN SEMIRIT ME SERAFO NON FOSTER CARE

“**Serafo**” non ei taropwe a wewe ngeni ekkewe non foster care rese mwo tori engon me wanu ierir ika “young people” ika “young person” pun “normal” wewen ach kunok ren emon aramas nge esapw emon “foster kid”.

“**Youth Voice**” a ngeni ekkewe semirit ar fansoun ar repwe uwau meifer me ar mochen, need me ar osukosuk non ewe neni mi nukunukeoch. Youth Voice mi pachenong foforan “authentic youth engagement”ⁱ, nupwen serafo ra pachenong non ekkoch mwokutukut mi apochokuner me apwapwar fanitan och mettoch. Ra pusin tumwunu inisir me eaea ar sinei non iimw, nukun, me on pusin inisir. Watte ra fori pwomwan ar angang non Youth Voice ar chiechi fengen ne anisi ekkewe kukun semirit. Mwan/fefin ir repwe apochokuna chon sukun repwe pusin tumwunu inisir, watiw ar aninis ngeni ekkewe serafo ika semirit, me anisir ika repwe need aninis.

Nupwen serafo ra pusin tumwunu on pusin inisir, ra awateino ar tufich me akukunano feiengawan mwokutukut me ekkoch mettoch ese eoch. Nupwen serafo ra fokkun pochokun me tongeni ar repwe mengungu me anei aninisir ar repwe pusin finata met repwe fori, ra poputa ne empowered iwe ren ei mi angawa nonomwur. Emon aramas mi chok serafo i mi need ekkei sakkun aninis me practice nupwen repwe watt ear repwe mamarita me pochokun non ar nonom.

Serafo re eaea ar sinei me non iimw, sukun, angang, nenian safei, tumwun me pusin on winikaper. Ekkoch awewe ren serafo ar eaea ar sinei:

Emon serafo a mochen kut an angang murin sukun nge Ir mi chok 16 ierir, ewe ier ka tongeni angang me Hawaii. Ra eisini nour kewe chon aninis me chon tumwun ika ir mei tongeni kuta r angang arap ngeni ar nenian sukun me pwon pun repwe achocho non ar kaeo pwan save-ini niwinir non ar bank account.

Emon serafo a mochen sotuni an epwe fiti urumwot non sukun. Ra eisini nour kewe chon aninis me chon tumwun ar repwe anisir me kutta pisekir pwan tungor ren ar repwe uweir ngeni ar nenian urumwot ika repwe fiti ewe urumwot.

Emon serafo a mochen play basketball ren an high school. A tungorei noun we resource caregiver me social worker ren aninis ne kutta aninisin ika monian pisekin ren uniforms me pisekin urumwot me pwan waan ne no ngeni an practice me pwan niwin sefan.

“**Social Capital**” ew nikinik a for seni omw chiechi ngeni ekkoch seni omw nuku me kesiwinin mettoch.

“**Normal**” wewen me ren ekkewe semiritin foster care, fiti chochon ewe faminian tong, aniniseoch, chiechioch, ir mi fifiti ekkewe mwokutukut iteitan ran, ren emon aramas, esapw chok och iit, me finata, sotuni minafon mettoch me fan ekkoch fori mi mwan. Kaeo seni met mi mwan nge kosapw nounou ne ureni emon semirit ika serafo an epwe tou/suno.

“Pisekin appet” chon tumwun ika resource caregivers me on-site CCI caregivers repwe forata ekkoch mettochun appet an epwe akukunano tumwunungawan me afeiengaw ngeni semirit, ekkei pisekin appet mi pachenong:

- **Serafo mi Pochokun**-anisi semirit/serafo ar repwe tongeni kinamwe me pochokun nupwen repwe mefi nipwakingaw me osukosuk; mamarita me eochun kesiwin ina eochun.
- **Social Connections**-anisir ar repwe chiechieoch ngeni aramas, mwiich, me aterenges pwan mwut ngenir ar repwe poporaus.
- **Fefeitan/mamaritan an semirit me serafo sinei**-weweiti sakopaten mwokutukutun serafo; fori angangaochun fofor me anisi semirit/serafo ar repwe mamarita me sinei mettoch.
- **An Semirit Sopwoch non Nonomwur me Mokurer**-anisi ewe semirit/serafo ren mwokutukutun me mamaritan an epwe sinei met epwe fori pwe epwe fokkun sopwoch, pwapwa me kinamwe ika a watte.
- **Apochokuna aninis non fansoun need**-Anisi semirit/serafo ar repwe weweiti namwotan/aucheian tungoren aninis me anisi emon, an epwe tori aniniseoch me sufon, awora fansoun an epwe watteno an sinei, me pochokun non ekiekin.

Ewe Appetin Foforungaw/Amomo Aramas me Apochokuna Angangan Famini (Public Law 113-183)

Ei mwokutukut a sain non annuk on September 29, 2014, a fori an epwe awatteno an ekkewe semirit/serafo fansoun non foster care ar repwe fiti ekkewe pekin mwokutukut ren saai, (sleep overs) mour non ekkoch neni me fori ekkoch mwokutukut. Ekkei fofor mi mwut ngeni ekkewe semirit ar repwe poputa ne kaeo, nupwen ar fori ekkoch mettoch ren chiener me pwan ekkoch aramas. Minafon mwokutukut me niknik- pwan mwo eochun fofor me finata – mi pwan anisi semirit/serafo ar repwe sinei ir io me kaeo auchean mwokutukut nupwen ekkewe chon aninis repwe anisir/tumwunur. Ewe minafon annuk a require ekkewe states ar repwe anisi mamaritan serafo me tumwunur seni met ir mi airi seni ewe “reasonable and prudent parent” taropwen appiru ren memef seni ekkewe caregivers me on-site CCI caregivers.

I. Mwokutukutun Aucheian omw Finata fanitan Pochokunan me Tumwunun Semirit me Angangeochun Iin/Sam

1. Prudent Parent Standards (Angangeochun/Tumwunuochun Iin/Sam Ngeni Semirit fanitan Tumwun me Pochokunan Semirit)

- a. **Ewe mwokutukutun auchean omw finata fanitan pochokunan me tumwunun semirit me angangeochun iin/sam** a feito seni angangeoch, me finieoch ngeni pochokunan me tumwunun semirit me pwan apochokuna ngeni ewe semirit an epwe mamarita nge epwe sinei met ekkewe caregiver ika on-site CCI caregivers repwe finata ika mwut

- b. Ren porausan ei mwokutukut mi require ekkewe resource caregivers me onsite CCI caregiver ar repwe sinei me weweiti pochokunan me mochenin ekkewe semirit/serafo re nomw non ewe iim/neni. Resource caregivers me on-site CCI caregivers re need ar repwe poraus, anea me nomw ngeni ekkewe semirit, nge met resource caregivers me on-site CCI caregivers repwe wessen need ar repwe sinei ren ifa usun ar nomw ngenir mi awora sokkonon mwokutukut, sinei me ekiekin ekkewe semirit/serafo.
 - c. Emon me emon semirit/serafo mi nom non foster care, ese nifinifin ir seni ian, met terir, nengin/at, ierir, me ar namanam, mi wor ar **pwuung** ar repwe fiti ekkewe mwokutukut me niknik mi tawe ngenir.
 - d. Meinisin resource caregivers me on-site CCI caregivers repwe eaea ewe reasonable me prudent parent standard ar repwe sinei ika repwe mwut ngeni ekkewe semirit/serafo ar repwe fori eochun niknik me non sukun, nukun sukun, me social ika cultural activities.
 - e. Resource Caregivers me on-site CCI caregivers repwe awora ew (nurturing environment) mwican tumwun an epwe apochokuna mwokutukut me mamarita pwan awora ew auchaean pekin kaeo ngeni famini.
 - f. Resource Caregivers me on-site CCI caregivers repwe aninis ren tumwunun non ewe healthy development ren semirit/serafo seni met ir mei wanong me fori an epwe anisi pochokunan me tumwunun ekkewe semirit me met ir mei pwapwaiti. Ekkei decisions mei pachenong ekkoch angang weires mi apochokunok mi fer seni iin/sam ren ekkewe semirit rese nomw non foster care. Ei mwokutukut mi for an epwe awora foforum "normalcy" me fansoun omw kopwe nomw non mwokutukut mi apochokunok mi pwan ngeni meinisin sakopaten aramas. Ewe reasonable me prudent parent standard epwe poputa ne mwokutukut fanitan omw sotuni/fori pwan ina sopwosopwun omw mamarita.
 - g. Resource caregivers me on-site CCI caregivers repwe pwan fori ar aninis me non ar famini, chiechier, me aterenges ar repwe anisi mamaritan me tumwun semirit/serafo.
 - h. Resource Caregivers me on-site CCI caregivers repwe fori pwan apochokuna **protective factors** ren akukunano feiengaw me tumwunungaw, ekkewe **niknik** mi pachenong: omw nukunuk, chiechi ngeni ekkoch, sinei non omw mamarita, an semirit angang me fofour, me apochokuna aninis non fansoun need.

2. Ekieki ren Mwokutukutun ewe Angangeochun/Tumwunuochun lin/Sam Ngeni Semirit fanitan Tumwun me Pochokunan Semirit

Nupwen eaean ewe reasonable me prudent parent standard, ew me ew resource caregiver me on-site CCI caregivers repwe ekieki ekkei mettoch:

- a. Ierin ewe semirit, an a watte, me ukukun an sinei an epwe maintain an pochokun me tumwun.
Awewe: Ika mwo emon semirit ierin 14, ewe kachito ren PG-13 movie mei wor content ren an semirit esapw tongeni fori nge esapw wor foforungaw ika pochokunan poraus?
- b. Ei potential risk factores me eochun ewe fofor me non sukun, nukun sukub, ika pwan ekkoch nikinik.
Awewe: Met osukosuk mi sokono omw kopwe mwut ngeni emon serafo epwe fiti chiechian ngeni sukun ika mwut ngeni ewe serafo epwe fiti chienan ngeni ew concert ika pari nepwin?
- c. Met mi apwapwai ewe semirit, anongonong on sineian ewe resource caregiver me on-site CCI caregiver.
Awewe: Ewe overnight camp a kefinita pun mi fit ngeni mochenin ewe semirit me pwan ina met e mochen fori, ika iei ew minan mwut ngeni ewe resource caregiver ika ewe on-site CCI caregiver an “ngaseta”?
- d. Aucheian apochokuna mamaritan me pochokunan ewe semirit.
Awewe: Fiti soccer ika football team mi anisi an ewe semirit epwe wor an nukunuk me awateno an kaeo?
- e. Omw etiwa me awora ngeni ewe semirit nenian ina met mi auchea.
Awewe: Iei och mettoch ewe resources caregiver ika on-site CCI caregiver epwe mwut ngeni noun ika noun mwumwu (semirit) epwe fori? Iei och mettoch epwe appeti ewe mwokutukiut me annukun ewe mwich?
- f. Ewe mwokutukut, memef, me aweiresin manawen ewe semirit me an ewe semirit tongeni an epwe tumwun ne fiti ekkewe mwokutukut.
Awewe: Ngeni ei semirit porausan foforungawan nisou ngeni chommong chiechier, mi mwut ngeni an epwe pusin imwuno on an epwe finioch non an finata? Ewe semirit a fen angei mettochun aninis an epwe finata met mei eoch?
- g. Ekkewe anean me mochen ren emon serafo.
Awewe: Emon serafo a mochen epwe sa on skateboard. Ifa taman an wawa ewe skateboard? Ifa usun an epwe tumwun? Ian ewe semirit/serafo epwe wawa ewe skateboard ian non ewe nenian skate ika park? Met ewe semirit/serafo epwe pipisek ekkewe pisekin appet?

3. **APOCHOKUNA GENI EKKWE RA IERIN FORI MWOKUTUKUT ME GENIR FOFORUN “NORMALCY”**

Namotan ar repwe topweno murin ekkewe annukun ewe angangeochun/tumwunuochun iin/sam ngeni semirit fanitan tumwun me pochokunan semirit non nonomwun emon semrit ren omw kopwe sotuni ne fori me sinei mwokutukutun ewe semirit me serafo ar repwe tongeni sinei pun meinisin repwe fori ena esisin ren mamaritar me tumwunur seni ne kukunur tori ar watte.

- a. Apochokuna ewe semirit/serafo, anongonong on ierir me ukukun ar tongeni, ar repwe tongeni fiti ekkewe mwokutukut mei eoch ngenir ren social me extracurricular events, tumwunun semirit, anini/kaeo ika pusin mochenir ar repwe fori mettoch ika angang, churi ar famini, me sinei nounoun fon.

- b. Fori met mei namwot, ierum ren curfew me apwonuweta fansoun mi affat.
- c. Mwut ngeni epwe fiti angangan computer ika foforan electronics, mi pachenong nounoun cell phones me social media (poraus online) nge epwe mwumwuta ika fan nemenian ekkewe resource caregivers me on-site CCI caregivers.
- d. Mwut ngeni ewe semirit/serafo ar fansoun ne kunou ren met mei fifis ika met mei normal. Ewe semirit/serafo epwe meni fiti kukunou nepwin ika planini an epwe no kunou an epwe anisi nonomwun, ika pun ewe licensed resource caregiver me ewe on-site CCI caregiver repwe finata nge ewe kunou epwe eoch pwan tumwun.
- e. Asinei ngeni ewe chon angangan Child Welfare Services (CWS) an epwe nomwono unusan ew pwiin anapano ren ru pwiin, me mwan ewe mettoch epwe fis.
- f. Kopwe pwan sinei met inan me saman ewe semirit ir mi wanong fanitan ekkewe mwokutukut ir mei mochen nour we semirit epwe fiti, me inet epwe tufich ngeni, apacharenong non omw kokot.
- g. Background screening ese namot ngeni emon semirit an epwe fiti sukun ika mwich me mwokutukutun eoreni pwan kunou, ren an sukun field trips, dating, camping, mouruno non ew neni me kukunou ngeni chiechiom, famini, sukun, me mwiich non faan.
- h. Affata ren ier mei eoch me mumuta me apochokuna ren pekin kokotun moni.
- i. Pwarata an semirit/serafo aukukun ar sinei nupwen ar nonom non foster care mei usun chok pwan an ekkoch semirit mi wewe fengen ierir.
- j. Kutta ew fansoun omw kopwe aitir ar repwe pusin fori on inisir, poputa seni ne kukunur. Ngenir mefier, apochokunar, atures ngeni me mwut ngeni emon semirit an epwe fori mi mwan in anen an iin/sam aiti ngenir ar repwe tongeni fori on pusin inisir.
 - 1. Weweiti pun manawan serafo mei aweires nge mei normal pwan pochokun. Serafo ir mei fori och angang mei ariafou ren aukukun ar tumwun me nonomwur, mei pwan mwut ngeni serafo ar repwe fori me kaeo seni met re fori mei mwan non ewe neni ir mi nonom non.
 - 2. Semirit/serafo resapw nuokus ne nusuni nenier ika re fori mettoch ese pwung.

4. Poraus me Aninis

Resource caregivers me on-site CCI caregivers fan ekkoch ir mei tongeni poraus ngeni ewe chon angangan CWS me ekkoch nupwen repwe pwungupwung on met repwe fori ika rese konien sinei ika osukosuk fanitan foforan ewe taropwen aureur. Ir mei pwan tongeni poraus ngeni ewe semirit/serafo me ar we team (CWS worker, GAL, therapist etc...) ika ir mi need aninis ika training ren ifa usun ar repwe anisi ekkewe serafo ren osukosuk fanitan eoreni, neni, namanam mi pwan affat ren osukosukan nonomwur ren at/nengin.

Resource caregivers me on-site CCI caregivers repwe pwan awora aninis, me amwicha ew aterenges non anukunuk ren ekkewe semirit/serafo, nge repwe achocho ne kutta ar aninis nupwen repwe need ar fori ei.

5. Met mi fis me mwan Kapwung

Mefian ewe resource caregiver me on-site CCI caregiver ren normalcy activities esapw tongeni epwe contrary ngeni ew akomwan court order. Awewe, ika mei wor ew court order visit ngeni inan/saman ewe semirit non Ran-Ammon, ew “normalcy activity” mei ketiw seni ewe resource caregiver me on-site CCI caregiver resapw awasano ika fori me mwan ewe akomwan court order fanitan ar chufengen non Ran Ammon.

Ewe Department epwe asinei ngeni ewe resource caregiver me on-site CCI caregiver kunokun/fansoun ewe court order an ewe resource caregiver epwe fori an akkot ngeni ewe semirit/serafo.

6. Kapas eis an epwe anisi resource caregivers ren foforun ika finatan “normalcy”:

- Ei mwokutukut mei awora eochun social development?

- Met ei mwokutukut mi angawa ewe court order?
- Kunokun ei activity epwe weneiti an chon non omw famini etto visit, counseling appointment ika doctor's appointment?
- Met nei we semirit/serafo mi sinei io epwe kokori me sinei met epwe fori ika a wor emergency ika mettoch mi atapwanapwan?

Awewe, serafo ir mei pwopwo ika mei worn our me ekkewe mei wor terir ir mei need aninis ar repwe fiti ika nomw non ei/ekkei eochun mwokutukut. Pwarata me akkota ekkei pekin aninis pwan iei sopwosopwun exercising the standard iwe epwe pwan nomw non ei case plan.

Ekkei pwuung ese keuk seni ekkewe taropwen aureur. Me nukun ena, ekkei mettoch epwe nomw non ekiekum nupwen emon epwe eisinuk kopwe fiti ew mwokutukutun mwichefen me nupwen emon epwe pachenong non ew foforun mwichefen ren resource caretaker's me on-site CCI caregivers.

(Sufon mei pwan need ren foforan ekkoch mwokutukut ren LGBTQ ren an epwe fat pun ekkewe semirit/serafo non foster care ir mei tumwun pwan pochokun).

Resource Caregivers me on-site CCI caregivers repwe kutta aninis me porausan aninis me fansoun ren semiritan LGBTQ me serafo ika rese mwo sinei porausan me kutten aninis ren chon angangan CWS, therapist me ekkoch chon aninis nupwen repwe need. Ren an emon serafo epwe kutta menni activities epwe mochen ngeni me need, nenian aninisin activities epwe meni towaw nge mei pwan mumuta sein aninis me kesiwinin ika forum ewe curfew ika fansoun niwinsefan.
